

**TCRC Waiver of Liability, Release, Assumption of Risk & Indemnity Agreement**

For and in consideration of Participant’s registration and payment of all respective fees, the participant below is granted access for the use the sand volleyball courts located at Three Chopt Recreation Club, Inc. (“TCRC”) located at or near 2100 Skipwith Road, Henrico, Virginia.

The Participant or parent(s) or legal guardian(s) of Participant relinquish any and all liability for and cause of action for personal injury, property damage or wrongful death occurring to Participant arising out of usage of the facility, the sport of Volleyball, and/or activities incidental thereto, whenever or however they occur and for such period said activities may continue, and by this agreement any such claims, rights, and causes of action that the Participant may have are hereby relinquished and the Participant (and/or parent(s)/guardian(s)) does (do) so on behalf of my/our and Participants heirs, executors, administrators and assigns.

Participant and/or Participant’s parent(s)/guardian(s) acknowledge, understand, and assume all risks inherent in Volleyball and any team activities, and understand that **said sports and activities involve risks to Participant’s person including bodily injury, partial or total disability, paralysis, and death, and damages which may arise therefrom and that I/we have full knowledge of said risks.**

The negligence of the Participant or the negligence of others, including the “releasees” identified below may cause these risks and dangers. It is further acknowledged that there may be risks and dangers not known or that are not reasonably foreseeable at this time.

Participant and/or Participant’s parent(s)/guardian(s) acknowledge, understand and assume the risks, if any, arising from the conditions and use of sand volleyball courts, or any other equipment or activities and related premises and acknowledge and understand that included within the scope of this waiver and release is any cause of action arising from the performance, or failure to perform maintenance, inspection, supervision or control of said areas and for the failure to warn of dangerous conditions existing at said sand volleyball courts, and for negligent selection, supervision or instruction of certain releasees.

**Participant or Participant’s parent(s)/guardian(s) agree that if any claim for Participant’s personal injury or wrongful death is commenced against releasees, he/she shall defend, indemnify and save harmless releasees from any and all claims or causes of action by whomever or wherever made or presented for participant’s personal injuries, property damage, or wrongful death. It is understood that Participant or Participant’s parent(s)/guardian(s) must use their own insurance or take full responsibility for any costs or damages incidental to the accident or injury, including wrongful death, that may occur.**

It is the purpose of this agreement to exempt, waive and relieve releasees from liability for personal injury, property damage, and wrongful death caused by negligence, including the negligence, if any, of the releasees.

“Releasees” include Three Chopt Recreation Club, Inc., its members, employees, volunteers, and Board of Directors, as well as any sponsors, and advertisers.

**Participant and/or Participant’s parent(s)/guardian(s) acknowledge that they have been provided and have read this Waiver of Liability, Release, Assumption of Risk & Indemnity Agreement, and have not relied upon any representations of Releasees, that they are fully informed of the potential dangers of Volleyball and any other activities available on TCRC property and understand these waivers and releases are necessary to allow the Participant’s usage of the TCRC premises.**
